Home Banking is available and is a free service. You can access your accounts 24/7 via any internet connection at www.itsme247.com, our Credit Union ID# is 123, and you will need your account number and pin. Some of the features include: free bill pay service, review accounts and rates, view cleared checks, access copies of checks, view history, make transfers and loan payments, open CD's, access statements, apply for a loan, plus much more.
